

CHECKLIST

REQUIREMENTS IN RESPECT OF REGISTRATION AS PESTICIDE DISTRIBUTOR IN SINDH

1. Application on prescribed proforma
2. Attested true copies of memorandum articles of Association or partner-ship deed registrar of firm/companies along with copies of NIC of Directors of firm/ company
3. In corporation certificate/certificate from registrar of firms
4. Audit reports of last 3 years (For Renewal of Registration)
5. Income Tax certificate/ sales tax certificate of distribution.
6. Agreement for packing and filling.
7. Agreement with the importer along with product registration Certificate.
8. List of technical staff, Degree certificate, PRC, NIC appointment letter, Acceptance, Authority to use vehicle & contact Telephone No. (As per SRO 21(1) 2004).
9. Copies of vehicle registration or lease agreement along with copies of NIC of owner.
10. Store / re-packing and filling certificate along-with checklist under APO 1971 by DDA/ ADAE concerned / PPO Sindh
11. Owner ship or registered lease/ rent agreement of store along-with copy of NIC of owner of store and copy of storeowner ship / documents.
12. Bank certificate of amounting to Rs. 1 million & bank statement.
13. Copy of under taking for contract spraying
14. Membership certificate from Crop life Pak or PCPA.
15. Copy of challan worth **Rs. 200,000/-** (New)/ **Rs. 100,000/-** for renewal.
16. Farmers and Dealers Training Programme / Training Plan
17. Copies of registration as pesticide Distributor in other provinces.

11. Undertaking.
12. Fee of Rs. **50, 000/-** for New, and Rs. **25, 000/-** for Renewal. (**Nonrefundable**).
