## GOVERNMENT OF SIND IRRIGATION AND POWER DEPARTMENT

Karachi, January 1st 1982.

No. SOPP-5/6-73.—The following rules and conditions which are prescribed by the Government of Sind, for issuing certificates of competency under Rule 48, of the Electricity Rules, 1937, are published for General Information. These rules shall apply to whole of Sind Province.

#### **I—LICENSING BOARD**

1. Appointment of Licensing Board.—For carrying out the purpose of these rules, a Licensing Board (hereinafter referred to as "The Board"), representative of electrical interests in Sind, shall be appointed.

#### 2. CONSTITUTION OF THE BOARD —

- \*(1) The Board shall consist of:
  - (a) Additional Secretary (Power), Government of Sind, Irrigation and Power Department, Karachi. President.
  - (b) The Electric Inspector to Government of Sind,
    Karachi/Hyderabad Region. Vice-President.
  - (c) One representative of Karachi Electric
    Supply Corporation/WAPDA, Hyderabad not
    below the rank of Superintending Engineer. ... Member.
  - (d) One representative of Communications and
    Works Department of the rank of
    Superintending Engineer. ... Member
  - (e) One representative of Karachi/Hyderabad, Electrical Contractors Organization/Association. ... Member.

"The representativesmentioned in (1)(c) and (d) shall be preferably a Garduate in Electrical/Machanical Engineering from any recognised University, Institute of Pakistan or India or Institute of Electrical Engineering, London".

"The Vice-President, shall act as Secretary of the Board".

- 3. Function of the Board.—The functions of the Board shall be:—
  - (1) to grant licenses to Electrical Contractors;
  - (2) to conduct examinations for supervisors and wiremen;
  - (3) to grant certificates and permits to Supervisors and Wiremen;
  - (4) to deal with applications and testimonials found to be incorrect and to take such action as may be decided on;
  - (5) to hear and decide cases of malpractice by electrical contractors, supervisors or wiremen; and
  - (6) generally to carry out the provisions of these rules.

Any decision given by the Board in the execution of its functions mentioned in this shall be final, except in respect of matters falling under item (5) in respect of which appeal may be lodged by any aggrieved party to Government, within three months from decision of the Board, to be counted from the date of service of the letter conveying the orders of the Board.

#### \*4. Meetings of the Board:—

- (1) The Board shall ordinarily meet once in three months;
- (2) Ten days clear notice shall be given for a meeting; provided that in emergency a meeting may be convened at a shorter notice;
- (3) The notice shall be served on the members by the Secretary.
- \*\*5. Quorum.—Three members shall form a quorum at any meeting of the Board.
  - 6. Duties of the President.—The duties of the President shall be:—
    - (1) to preside at all meetings of the Board, unless prevented by reasonable cause; and
    - (2) to grant licenses to electrical contractors and certificates and permits to Supervisors and Wiremen on behalf of the Board.
- 7. Chairman of the Meeting.—The President and in his absence such one of the Members present, as may be elected by the meeting shall be the Chairman of the meeting.
  - 8. Duties of the Secretary.—The duties of the Secretary shall be—
    - (1) to scrutinize all applications for electrical contractor's licenses and submit the same to the President and carry on correspondance in connection therewith;
    - (2) to scrutinze applications for admission to the examination for supervisors and wiremen and carry on correspondance in connection therewith;
    - (3) to countersign licenses to electrical contractors and certificates and permits to supervisors and wiremen; and
    - (4) to notify to all electric supply companies concerned and the electrical contractors' association organization of all licenses issued and/or cancelled.

#### **II—EXAMINATIONS**

- \*\*\*9. Examinations.—Examinations under these rules shall be held once a year separately for Karachi and Hyderabad, Regions with respective centres at Karachi and Hyderabad, on such date or dates as may be fixed by the Board.
- 10. Admission to Examinations.—Examinations are primarily intended for candidates residing or actually working in Sind. Candidates outside Sind may, however, be admitted to an examination on payment of the prescribed fee in the manner specified.

#### III-MODE OF EXAMINATION

11. Every examination shall be of such a nature as to test the practical know-ledge of the candidate and to ascertain his competency.

12. Every examination shall be conducted in Karachi/Hyderabad, where the candidate's knowledge can be practically tested and each candidate shall be tested in viva-voce.

#### IV—ADMISSION OF CANDIDATES FOR EXAMINATIONS

- 13. Examination for Supervisors.—The examination for suppervisors is intended for electricians, supervisors, formen, charge-hands and others, but any wiremen, may appear for the examination, if he desires to do so.
- \*14. Qualifications.—No candidate shall be eligible to appear in the Supervisors Examination unless:—
  - (a) he is of at least twenty one years of age;
  - (b) he is certified by a registered Medical Practitioner to be physically fit;
  - (c) he has passed Matriculation Examination or an equivalent Examination from a recognised Board or University;
  - (d) he has passed Examination for Wireman; and
  - (e) he has atleast five years practical experience in electric trade, acceptable to the Board.

#### NOTES:-

(1) Examination under the old rules for failures.—Provided that a candidate who has previously failed in the examination shall have one chance to appear in the next examination under the old rules.

(2) Exemption from Supervisor's Competency Certificate Examination.—

A Candidate who posseses a degree in Electrical Engineering from any recognised University and at least one year's practical experience in Electrical trade after passing Degree or possesses three years Diploma or equivalent certificate in Electrical Engineering from any recognised Board or Technical Institution and atleast three years practical experience in electrical trade after passing Diploma may be exempted by the Board from passing the Supervisor's Examination subject to such tests as it may consider proper.

- 15. Examination for Wiremen.—The Examination for Wiremen is intended for working wiremen.
- \*16. Eligibility.—Every adult physically fit person having a minimum of two years practical experience in electrical wiring installations or allied work with any Licensed Electrical Contractor, Registered Factory, Cinema and or any Government or Semi Government Institution, shall be elegible for admission to the Wiremen Examination on payment of prescribed fees and on production of Identity Card.

NOTE (1) Exemptions from Wiremen's Examination:

A candidate who possesses the following qualifications and experience may be exempted from passing the wiremen's examination of the Board subject to such tests as it may consider proper:—

- (a) passed 18 months or one year wiremen course from any School or Institution approved by the Board;
- (b) successfully completed an apprenticeship or practical training for a further period of six months or one year so that a full period of 2 years, has been served, subject to such tests as may be considered proper by the Board,

- (2) A candidate who is physically fit and possesses original certificate of competency or permit for electrical supervisor/wireman from any other Province in Pakistan or a foreign country issued by competent authority shall be entitled to an equivalent exchange certificate or permit on payment of prescribed fees subject to such tests as may be considered proper by the Board; provided that the candidates for supervisor's exchange are Matriculate and not less than 21 years of age.
- 17. Application for appearing for Examinations.—Every candidate for an examination under these rules shall make an application in Form-A-1 and A-2, and shall sign the same in the presence of his employer/Honorary Magistrate or a Government Officer. The candidate shall forward the application duly filled in to the Secretary to the Board not more than \*thirty days before the date fixed for the examination together with:—
  - (a) testimonials of-
    - (i) good character; and
    - (ii) practical experience as a wireman.
  - (b) Wireman's examination certificate, if any;
  - (c) a challan/pay order in support of payment of the fee; and
  - (d) three copies of his latest photograph (size about  $2'' \times 2\frac{1}{2}''$ ) with his name on the back.
- 18. Examination fee not to be Refunded.—The fee paid by a candidate, whose application for an examination has been accepted, shall not be refunded to him on any account.

Provided that in the event of a candidate's inability to attend the examination for valid reasons, it shall be competent to the Board to allow such candidate to appear at the next examination without further payment.

#### V-TESTIMONIALS

- 19. Admission to Examinations.—No candidate shall be admitted to any examination whose testimonials are, in the opinion of the Board, unsatisfactory.
- 20. Return of Testimonials.—The original testimonials after being scrutinized shall be returned to the applicant when his application is disposed of.

#### VI—SUBJECTS FOR EXAMINATIONS

- 21. Syllabus for the Examination of a Competency Certificate.—Candidates for the examination of a competency certificate shall be examined by a written paper and by an oral test in accordance with the following syllabus:—
  - (a) Electrical Units.—Ohm's Law-Calculation of "Drop" and size of conductors for various loads and length of run. Resistance and insulation resistance and their measurement.
  - (b) Electrical current.—Its calculation and Measurement-Current carrying capacity of conductors—effect of heat on conductors.
  - (c) Electrical Power.—Measurement and calculation of power consumed by motors and other consuming devices-conversion of H.P. into K. W., Power Factor, Low and Medium Pressure Power transmission and distribution methods and calculation.
  - (d) Electric Energy.—Methods of measurements and calculations of costs, of energy.

- (c) Electrical Measuring Instruments.—Priciples and connection of Ohm meter, Voltmeter, Ammeter, Wattmeter, Energy meter, Frequency meter, Power Factor meter and Synchronoscope.
- (f) Storage Batteries.—Main principales, calculations of capacity, installations, ecertion and connection. Importance of specific gravity and voltage readings-maintenance. Battery Boosters-their connections and operation.
- (g) Electric Mechines.—Elementary theory, installation, connection, operation and repair of the following:—
  - A. C. Single and Polyphase Alternators including parallel running of same;
  - A. C. Single and polyphase Motors-Sychoronous and Induction Types (including Squirrel cage and wound rotor types);
  - A. C. Single and Polyphase Transformers for medium and high pressures;
  - D. C. Dynamo.—Series, Shunt and Compound Wound Types-Parallel running of Dynamos;

Rotary Convertors and Balancers;

- D. C. Motors.—Series, Shunt and Compound Wound Types;
- Testing of D. C. and A. C. Machines for faults and insulation; Care of Brushes, Commutators, Slip Rings, Bearings, etc.,

Theory and Practice of Armature Winding small A.C. and D.C. machines.

(h) Control Gear for A.C. and D.C. Machinery.—Various types of switch gear, fuses, regulators, motors, starters, relays, overload and non-volt releases and other safety devices, auto-cut outs, circuit breakers etc.,

Their uses and connections.

- (i) Electric lifts.—General principles-Controller and Camswith, also push button control, connections and safety devices. Maintenance of lift Machinery.
- (j) Electric Pumps.—General principles and elementary claculations of head; power and energy consumption.
- (k) Electrical Appliances.—Heating, cooking, refrigerating and other motor operated appliances, time switches, thermostats, electromagnets, etc., their principles, connections and elementary calculations.
- (l) Electrical Power-Plant.—Calculations, erection, running and maintenance of small engine driven plants with storage bettelies.
- (m) Electricity Act.—The Electricity Act, 1910 and the Electricity Rules, 1937.
- (n) Installation Wiring.—Various methods of wiring and distribution, installation maintenance-systematic testing of installations-location and repair of faults-earthing of installations. Wiring and installation accessories and their uses. Different kinds and sizes of wires and cables their use sand calculation of sizes, making wiring schedules and wiring diagrams for installations.
- (o) Illumination.—Types of electric lapms and their uses. General principles of illumination and elementary calculations.

- (p) Bells and Telephones.—Wiring up and connection of Bell and Telephone circuits.
- (q) Overhead Lines.—Simple calculations, and construction for low, medium and high pressures. Strength of poles, Wind pressures, sag, temperatures effects and tension on wire, insulators, brakets, guy wires, stay struts, guard wires, protective, outdoor fittings, lighting conductors and arrestors.
- (f) General.—Making dimensioned sketches and reading drawings (plans, elevations and sections), power and lighting circuit diagrams.

  Resuscitation from electric shock.
- 22. Syllabus for Examination for Wiremen.—Candidates for the examination for wiremen shall be examined practically in wiring and pointing and by an oral test in accordance with the following syllabus:—
  - (a) Us of standard wire Gauge.
  - (b) Use of test lamps.
  - (c) Use of Bell and Battery for sorting out circuits.
  - (d) Method of testing polarity.
  - (e) Connection and diagrams for distribution and fuse boards, cut-outs, ceiling roses, lamp holders, switches (including two-way and intermediary).
  - (f) Wiring Cleats, wood casing lead-covered, C.T.S. and conduit.
  - (g) Wiring of fittings and other consuming devices.
  - (h) Connections of A.C. and D.C. Fans and Regulators.
  - (i) Repair of A.C. and D.C. Fans and Regulators.
  - (j) Methods of carrying (over head) bare, lead-covered and C.T.S. wires over short distances.
  - (k) Jointing: -
    - (a) Making straight and Tee Joints in stranded insulated wires.
    - (b) Making Britaina and Western Union Joints in bare copper wire.
  - (l) Soldering lugs on wires and cables.
  - (m) The installation of electric bells and indicators.
  - (n) Testing.—Faults and Breakdown in installations.

#### VII—CERTIFICATES AND PERMITS

- \*23. Grant of Certificate of Competency and Permit to Supervisors: -
  - (i) Every candidate who secures forty percent marks in individual subject and forty five percent marks in the aggregate shall be declared to have passed the Supervisor's Examination.
  - (ii) Every candidate who has passed the Supervisors Examination or has been exempted from passing such examination or has been allowed exchange of permit under Rule 16, shall be granted a Certificate of Competency in Form B or C, as the case may be and a permit in Form D.

(i) Every candidate who secures forty percent marks in individual subject and forty five percent in aggregate shall be declared to have passed the Wiremen's Examination.

- (ii) Every candidate who has passed the Examination for Wiremen shall be granted a certificate in Form E and a permit in Form G.
- 24-A. (1) A permit granted under rule-23 or 24 shall be valid for a period of three years and may be renewed for further term of three years by the Electric Inspector or the Assistant Electric Inspector on payment of fees mentioned in rule-48.

Provided that no permit shall be renewed if the permit holder: —

- (i) Dies;
- (ii) is convicted for any offence by a court of law;
- (iii) becomes permanently disabled;
- (iv) is found guilty under rule 44 and 45.
- (2) The permit for renewal shall be presented one month before it is due to-expire.
- (3) No permit which has expired shall be renewed unless additional late fees mentioned in rule-48 is also paid.
- 25. Gram of Certificate and permit in Certain Cases.—Candidate exempted from appearing for the examination under the note to rule 16 shall be granted a certificate in Form F and a permit in Form G, on payment of the prescribed fee.
- \*26. Withdrawal, Suspension and Cancellation of Certificates and Permits.—
  A certificate or permit granted under these rules shall be liable to be withdrawn or suspended for such period as the Board may decide if the holder thereof is found guilty of negligence or malpractice or infringement of any of these rules or instructions issued from time to time and shall stand cancelled.
  - (a) on the death of the holder;
  - (b) on holder becoming permanently disabled; and
  - (c) on holder being convicted by a Court.
- 27. Grant or Duplicare Certi\*cate or Permit.—A duplicate of every Certificate and permit granted under these rules shall be recorded in the office of the Secretary.
- x28. Grant of Duplicate Certificate or Permit.—A duplicate of the Certificate and Permit granted under these rules shall be issued on payment of fees prsecribed and on production of proof, of the loss of the original certificate or permit to the satisfaction of the Secretary of the Board together with the latest copy of the photograph of the holder of such Certificate or Permit.

#### VIII—LICENCES TO ELECTRICAL CONTRACTORS

- \*29. Grant of Electrical Contractors Licences.—An Electrical Contractor's Licence shall be granted only to a person for a registered firm), if such person or firm:—
  - (1) holds a certificate of competency and permit and personally executes or supervises all work undertaken by it or him, or has employed a supervisor holding a certificate of competency and permit under whose direct such work is carried out and has in his or its employment atleast one licensed wireman.

- (2) has in possession the following instruments for carrying out tests required under the Electricity Rules, 1937:
  - (i) one insluation testing set of 500/1000 V, constant pressure type zero to infinity range;
  - (ii) one portable Voltmeter suitable for 0-500 V range;
  - (iii) one tong tester of 0-100 A, 0-500 V, range; and
  - (iv) one earth resistance tester of 0-10 ohms range.
- (3) (a) for the purpose of carrying out normal electrical contracting business maintains separate, independent, suitable business permises of not less than 6 sq. meters in a commercial Area/Bazar Main Road, to the satisfaction of the Secretary of the Board;
  - (b) has at its business premises sufficient quantities of various electrical wiring material and tools and a sign board of not loss than 1 sq. meter in area hung or posted at conspicous place to the satisfaction of the Secretary of the Board; and
  - (c) produces documentary proof to the satisfaction of Secretary of the Board for being owner or tenant of the premises.
  - (d) Produces a solvency certificate from a competent court or a Bank Guarantee to the tune of Rs. 10,000/-.
  - (b) Has no direct or indirect interest in more than two Electrical Contractor's Licences.
- Notes—1. All applicants for grant of Contractor's Licence shall get themselves registered with Income-tax Authorities of the Region and shall submit G.I.R./T.R. Registration Certificate.
  - 2. All applicants in partnership for grant of contractor's licence shall submit partnership deed registered under the Registration Act, 1908.
  - 3. The existing Licensed Contractors shall obtain new licences under this rule within one year of its enforcement.
  - 4. Every supervisor or wireman in the employment of a Licensed Electrial Contractor shall submit an affidavit on a stamp paper duly attested by a First Class Magistrate and a declarations in form K or L and M or N, respectively as the case may be.
  - 5. The Board shall be competent to relax for a specified period the condition of having any testing instruments which are not readily available in the market during that specified period.
    - 6. If a Licensed Electrical Contractor at any time desires to shift his business premises he shall intimate atleast one week before shifting to new premises alongwith the address and rent receipt of the new premises and have the same inspected on payment of prescribed fees.
    - If at any time the Licensed Electrical Contractor fails to maintain his business premises as defined in Rule 29(3) his license shall stand suspended.
- 30. Form of Contractor's License.—The Electrical Contractors License shall be in Form H.
- 31. Electrical Contractor to Keep Instruments in Good Order.—An Electrical Contractor to whom a license in Form H, is granted shall keep the instruments necessary for carrying out the tests required under the Electricity Rules, 1937, in good order.

- \*32. Cancellation of Contractor's Licence.—If the holder of a Competency Certificate on the strength of whose permit a licence has been granted to an Electrical Contractor, leaves the service of such contractor, such contractor's licence shall be deemed to have been cancelled unless such contractor employees a person holding a certificate aforesaid within one month from the date on which such holder had left such contractor's service.
  - \*33. Notice of Termination of Service of Supervisor.—
  - (1) If a holder of Supervisor's permit in the employment of a licensed electrical contractor leaves the service or his services are terminated, the termination of the service shall be notified to the Secretary of the Board both by the Contractor and the permit holder.
    - (2) The Contractor shall notify the name and certificate and permit number of the supervisor engaged by him and shall submit the permit to the Secretary of the Board for endorsement.
- 34. When Contractor's License shall not be Granted—A contractor's license shall not be granted to any holder of a supervisor permit whilst he is in the employ of a firm of electrical contractors.
- 35. Cancellation of Contractor's License.—If a holder of a supervisor's permit to whom a contractor's license has been granted accept employment in any other firm of electrical contractors, the contractor's licence to such holder shall be automatically cancelled.
- 36 Inspection of Instruments.—All testing instruments in the possession of every electrical contractor shall be inspected from time to time by the Electric Inspector or his representative.
- 37. Staff of Contractor.—The entire staff of every Licensed electrical contractor shall consist of bonafide certificated and full time employees, provided that the contractor may engage apprentices for training purposes, in which case the total number of Apprentices employed by any contractor at any time shall not exceed 50% of his total wiring staff, inclusive of Apprentices but exclusive of coolies and provided, further that the contractor shall not permit such Apprentices to carry out any electrical installations work, including additions, alterations, repairs and adjustments to existing installations covered by Rule-48 of the Electricity Rules, 1937, except under the direct supervision of a person holding a certificate of competency and under the guidance of at least one certified wireman on the premises.

Every contractor shall maintain a Register in Form I of all Engineers, Supervisors, Wiremen and apprentices, such Register shall be obtained from the Electric Inspector, Karachi/Hyderabad, and shall be open to inspection at any time by that Officer or his representative.

No person whose name is not entered in such register shall be considered to be bonafide employee of the Contractor's wiring staff.

- 38. Application for Contractors Licence.—Application for a contractor's license shall be made to the Secretary in Form J.
- 39. Mode of Contract.—Every contract for electrical installation work undertaken by a licensed electrical contractor shall be in writing, and licensed electrical contractor shall be held responsible for the quality of all materials used.
- \*39-A Notice Before Commencement of Work.—No electrical installation work including additions, alterations, repairs and adjustments to existing installations except such replacement of lamps, fans, fuses, switches and other component parts of the installations as in no way alters its capacity or character shall be commenced by a licensed electrical contractor without notifying in Form P to the Electric Inspector or his Assistant.

- 40. Test Report.—For all electric installation work carried out under rule-48, of the Electricity Rules, 1937, a test report shall be submitted by the licensed electrical contractor to the Supply Company/Licensee concerned. The test report shall be signed by the supervisor under whose supervision the work has been carried out and countersigned by the Licensed electrical contractor. The supervisor shall be wholly responsible for the due execution of the electric installation work. It is highly desirable that the supervisor or a duly qualified representative of the electrical contractor should be present at the time of testing.
- 41. Register of Contractors.—A register of all licensed electrical contractors shall be maintained by the Secretary.
- \*42. Renewal of Contractor's Licence.—
- (1) Every Electrical Contractor's Licence granted under these rules shall be renewable every year in the month of January, on payment of the prescribed renewal fee or in the month of February, on payment of additional prescribed late fee.
- (2) An application for renewal of licence shall be submitted to the Secretary of the Board, during the month of December, along with:—
  - (i) Staff register in duplicate incorporating all the changes in staff, the intimation of which has been submitted under rule-37.
  - (ii) Testing instruments in working order with name and license No. of the firm engraved on the instruments.
  - (iii) Inspection Report of the business premises if the premises have not been inspected during the last currency of the Licence; and
  - (iv) Licence (in original) to be renewed.
  - (3) If the Licence is not got renewed within the stipulated period it shall stand cancelled and a new licence shall be issued on payment of initial fee fixed for issuance of a licence if any application is made during the same Calendar year in which the original licence was to be renewed.
- \*43. Grant of Duplicate of Contractor's Licence.—A duplicate copy of an Electrical Contractor's Licence shall be issued on payment of prescribed fees and on production of proof of the loss or mutilation of the original licence to the satisfaction of the Secretary of the Board.
- \*43-A A change in Name.—The name in the licence shall be changed on payment of the prescribed fee and production of Income Tax Clearance Certificate in the original name of the firm and G.I.R. No. in new name provided that no change shall be made if it involves a transfer of assignment of the licence to another person even through power of attorney.
- \*\*43-B. Fee for change of Ownership—The contractor's license is not transferable. If the original electrical contractor sells or transfers his concern to another person or firm, such person or firm must make an application in Form J, for a fresh license and pay the prescribed initial fee.

## IX—MISCONDUCT OF LICENSED CONTRACTORS, SUPERVISORS AND WIREMEN

44. Report of Negligence.—Where, in the opinion of a Supply Company/Licensee or a person for whom any electric installation work has been carried out, such work is not in accordance with the Electricity Rules 1937, the matter shall be reported to the Electric Inspector concerned for such action as may be necessary and the action taken by him shall be notified to the parties concerned.

#### \*45. Malpractice and Infringement of Rules:-

- (1) If any person or firm holding a permit or electrical contractor's licence is found guilty of mis-conduct, malpractice or infringement of these rules or instructions issued there under from time to time, the Secretary of the Board shall submit a report in this behalf to the Board.
- (2) The Board may on receipt of report under sub-rule (1) and after consideration of the same, pass such orders as it may deem fit; provided that no order shall be passed without hearing the holder of the permit or the licensed contractor against whom report is made if he wishes to be heard.
  - (3) The decision of the Board on such report shall be final and communicated to the person concerned.

## X—ELECTRIC SUPPLY COMPANIES/LICENSEES—CARRYING ON THE BUSINESS OF ELECTRICAL CONTRACTORS

- (a) No Contractor's Licence shall be granted to an Electric Supply Com-\*46. pany/Licensee unless in the opinion of the Board the grant of such licence is necessary in the public interest.

## CONDITIONS FOR THE GRANT OF ELECTRICAL CONTRACTOR'S LICENCE (RULE 29).

An electrical contractor's license shall be granted only to a person (or a registered firm) if such person or firm:—

- (1) holds a certificate of competency and permit and personally executes or supervises all work undertaken by it or him, or has employed a Supervisor holding a certificate of competency and permit under whose direct supervision such work is carried out and has in his or its employment atleast one licensed Wireman;
- (2) has in possession the following instruments for carrying out tests required under the Electricity Rules, 1937:—
  - (i) One insulation testing set of 500/1000 V, constant pressure type, zero to infinity range;
  - (ii) One portable voltmeter suitable for 0-500 V, range.
  - (iii) One tong tester of 0-100 A, 0-500 V, range; and
  - (iv) One earth resistance tester of 0-100 Ohms range.
- (3) (a) for the purpose of carrying out normal electrical contracting business maintains separate, independent, suitable business premises of not less than 6 Sq. meters in a Commercial Area/Bazar/Main Road, to the satisfaction of the Secretary of the Board;
  - (b) has at its business premises sufficient quantities of various electrical wiring material and tools and a sign board of not less than 1 Sq. meter in area hung, or posted at conspicuous place to the satisfaction of the Secretary of the Board; and
  - (c) produces documentary proof to the satisfaction of Secretary of the Board for being owner or tenant of the premises.
- (4) Produces a solvency certificate from a competent court or a Bank Guarantee to the tune of Rs. 10,000.00.
- (5) Has no direct or indirect interest in more than two Electrical Contractor's Licences.

#### NOTES: -

- 1. All applicants/firms for grant of Contractor's License shall get themselves registered with Income-Tax Authorities of the Region and shall submit G.I.R/T.R. Registration Certificate.
- 2. All applicants in partnership for grant of contractor's license shall submit partnership deed registered under the Registration Act, 1908.
- 3. Every Supervisor or Wireman in the employment of a Licensed Electrical Contractor shall submit an affidavit on a stamp paper duly attested by a first Class Magistrate and a declaration in Form K or L and M or N respectively, as the case my be.
- 4. If a Licensed Electrial Contractor at any time desires to shift his business premises he shall intimate atleast one week before shifting to new premises along with the address and rent redeipt of the new premises and have the same inspected on payment of prescribed fees.
- 5. If at any time the Licensed Electrical Contractor fails to maintain his business premises as defined in Rate 29(3) his license shall stand suspended.
